-Student interviews indicate that Mr. Perry speaks to them about evil spirits that are working through them,

-Students interviews indicate that Mr. Perry states that adult staff have evil spirits upon them that are working against the students. These people are praying for evil things to happen. -In class, uses comparisons of chain of events to students as "evidence" of his prior knowledge and/or understanding of what "is" happening, "going" to happen and "does" happen to people and their circumstance. These comparisons are used to support the transfer/evidence of evil spirits in operation and his knowledge of what is happening.

-Inferences made by Mr. Perry to students that if anything happens against him such as termination of employment, that the school will not succeed and something bad will happen

to the school.

-The singling out of students that speak to other adults or administration regarding things happening or said in the classroom - the inference is that they are being influenced by evil spirits. -Statements made by Mr. Perry regarding rebuking and discussion of evil spirits are contributing to the loss of students. Some students have expressed that they do not want to come to school/class and the recent loss of a student due to statements made by Mr. Perry.

-Insubordination of immediate supervisor by statements made to the class that allude to the ast istant

principal having evil influence over students in the class.

-Mr. Perry was in a prayer circle with the students in the classroom. After being told by his immediate supervisor that he could not do that, told the students several times; in her presence, to continue.

Summary:

Mr. Perry has shown defiance for the authority of his immediate supervisor in the presence of students by disregarding her direct order not to pray.

Statements made by Mr. Perry to students are unacceptable and inappropriate conversation (instruction). Mr. Perry has violated our personnel policy #1eb by discussion of dissatisfaction in the presence of students. These statements are intimidating and have served as a means of negative control over students. Statements made by Mr. Perry shows lack of good judgment and wisdom as an educator of his experience and background.

These issues, as listed above, do not align with the vision, objective or expectation of The Woodson Academy.

Recommendation:

Termination of employment by voluntary resignation or administrative termination effective immediately.
