Hello,

I am contacting you from the State of Wisconsin Educational Approval Program (EAP) regarding your recent inquiry about state approval requirements to offer your diploma program to Wisconsin students. I understand you've been communicating with Jed Oehler of EAP staff, who asked me to follow-up with you.

The EAP is charged with protecting Wisconsin consumers who enroll in private programs and trainings that have a vocational objective. For example, a welding program that specifically trains a student to seek employment as a welder or a dental assisting program that is a gateway to employment in the dental assisting field are subject to our agency's approval requirements. Alternatively, under s.440.52 (1)(e)4, Wis. Stats., "[s]chools primarily offering instruction avocational or recreational in nature and not leading to a vocational objective," are exempt from EAP state approval. Your correspondence to the EAP indicates that the program's objective is to "heal humanity spiritually and metaphysically through rigorous tasks of the implementation of love, justice and peace." It seems to me the training you intend to provide is more generalized and not tied to a specific vocation. As such, it would fall under the avocational exemption. Be advised that while awarding a certificate of completion for such a program may be appropriate, in order to award students any type of a degree (Associates, Bachelors, Masters, Doctoral), the program must meet specific requirements set forth by the federal government in terms of program duration and numbers.

Please note this exemption means only the EAP has no legal authority for oversight of the institution or its programs. This exemption does not imply any sanction or recognition by the EAP for either the institution or its programs. Moreover, you are advised to inform prospective students of the value, transferability and recognition of the courses.
